#### Society of Ohio Archivists' Program History

This document was written by Tom Steman, SOA program chair, 2000/2001. The purpose of this report was to document what topics were covered in which sessions for all SOA sponsored meetings. This should help the program committee organize SOA's semi-annual meetings. Obviously, without full written summaries of each session, it cannot be closely determined what each session covered (see *Ohio Archivist*, 1989-2001, for session reports). However, session titles will at least give an idea of the planned session topic.

The scope of this document was to provide the dates, place, session titles, and speakers for every SOA sponsored meeting. Session moderators or chairs were not included. Continuing education workshops, when identified, were also not noted.

It is hoped that this report will be a living, expanding, and active document. In a perfect world, the program committee chair will add to this report when an SOA meeting is finished. The final original document, as created by Tom Steman, was given to The Ohio State University Archives in February 2002 to add to the records of the Society of Ohio Archivists. An electronic copy was passed on to the current SOA program committee chair, Melinda McMartin.

Sources were consulted at The Ohio State Archives and Case Western Reserve University Archives, as well as privately-held materials.

#### SOA Programs 1966-1967

Two meetings were held for Ohio archivists before the Society of Ohio Archivists was officially organized on July 1, 1968. These two meetings, held in 1966 and 1967, led Ohio archivists to form a state-wide archives organization known as the Society of Ohio Archivists.
